



Attachment 4 Core Target Groups (Training)

1. Target Group – Foundation Skills specific

MAX Solutions – Foundation Skills delivers qualifications under 2 Australian Government contracts:

- 1. Skills for Education and Employment (SEE); and
- 2. Adult Migrant English Program (AMEP) subcontracted through NAVITAS English (not a Third Party Arrangement).

As a Registered Training Organisation (RTO 0667), MAX Solutions Foundations Skills' prospective students are typically:

- AMEP Program adult migrants from non-English speaking backgrounds and may include new or established migrants, refugees and high school students
- SEE Program aimed at eligible jobseekers and may include, Aboriginal and Torres Strait Islanders, Youth, People with disabilities, Mature-Aged people and jobseekers from culturally and linguistically diverse backgrounds.

Foundation Skills specific cohorts may have a limited range of language skills to engage with Australian contexts and/or are still developing the skills to engage in a limited and predictable range of community, work and educational contexts.

Students are often engaged by their employment agencies and recommended to undertake an appropriate course to assist in attaining employment. Students may be directed to the RTO through their jobactive, DES provider, Transition to Work provider, or other referring agency, or they may self-refer into the training (AMEP students). Jobseekers connected to agencies and receiving unemployment benefits may have mandatory requirements to participate in training and their activities and attendance will be reported back to the referring agency.

The cohort of students predominantly have limited to no experience within industry and may include one or more of the following characteristics:

- New to industry
- Disability Employment Services (DES) customers
- jobactive customers
- Culturally and Linguistically Diverse (CALD) Long term unemployed.

2. Target Group - VET (all other – accredited training)

MAX Solutions delivers qualifications by the following enrolment methods:

- Standard (non-funded) enrolment
- State Training Authority funded enrolment (STA)
- Traineeship enrolment
- School based trainee enrolment
- Fee for Service.

As a Registered Training Organisation (RTO 0667), MAX Solutions' prospective students are typically active job seekers needing support and training for entry-level employment within their chosen industry. These students are often engaged by their employment agencies and recommended to undertake an appropriate course to assist in attaining employment. Jobseekers connected to agencies and receiving unemployment benefits may have mandatory requirements to participate in training and their activities and attendance will be reported back to the referring agency.
